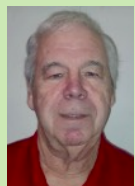

Legacy fund donations

The Dante Club Legacy Fund was created during the pandemic as a way for members to help the club through a difficult period.

The Dante board of directors has decided to reinvigorate the fund as one of five strategies to pay off the club's remodeling mortgage. Donations to the fund will help retire the mortgage early.

The Legacy Fund has three donation levels: platinum, \$1,000 or more; gold, \$500; and silver, \$250.

Donors will be recognized annually in the newsletter and at a members dinner. They'll also be honored on a plaque in the Dante Event Center.

Donations will be applied to the mortgage principal monthly.

Donors should mail or deliver a check to the Dante Club (attn: treasurer) and explain how the

donor or a person honored by the donor should be recognized—what name should be on the plaque and in the newsletter.

Donors may remain anonymous if they prefer.

Annual dinner payments

Members can pay monthly or annually for meeting-night dinners.

When paying in advance, members cannot receive a refund or a credit for any dinner they don't attend, but they don't need to tell the event center if they can't attend, as they have already paid.

The annual payment option is a convenience for those who don't want to pay monthly.

For reservation substitutions, members must call 916-925-8230 by noon the day of the event and give the substitute's name.

Any substitution not confirmed by noon on event day can't be honored.

The Ronald McDonald House charges \$20 per night for parents to stay there while their children receive treatment at UC Davis Medical Center.

The pull-tab program helps those who can't afford the cost by accepting donations of aluminum-can pull tabs, which it then sells for cash.

The Dante Club has donated to the program since March 2018. The Dante Women's Club also participates. Our two clubs have donated a total of 1,757.7 pounds of pull tabs to the Ronald McDonald House.

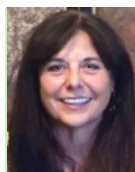

it if you hit it.” No idea what my father had to pay. I kept throwing, until eventually ... whack.

Then my family moved to Sacramento, but we didn't connect with an Italian social club right away. We still had crowded, noisy and fun dinners, but they were for 20 or 30 of our family, friends and neighbors at our home. We had select guests at the main table, others in the family room and kids in the garage. It wasn't a club, but we continued to celebrate our Italian heritage.

My brother finally took the first step and became a Dante Club member in 2002, followed by a son, a brother and two more sons. And here we are today, enjoying as many events as our schedules allow.

I then bought into the notion of how I and other members could keep this club going. The Dante

Club is also a facility requiring care, feeding, support and oversight. Our 20,000 square feet of buildings—plus a tent, gazebo and bocce courts outside—sit on 3.5 acres.

Over the next two years, my opportunity as president will be to take a larger role in promoting the continued vitality of our club. It takes a village of active members. Add in the importance of our centennial year, and I am a bit anxious about addressing our social and fiscal needs.

So now some obvious questions: Why are you a member? Are you getting all the social benefits you want? Are there too many of some things and not enough of others? Are there events from the past that you wish were happening now?
